ITEM AND ISSUE:

Request for the Approval of Amendment #1 to MOA with Santa Fe County in the Total Amount of \$0 for the jointly funded SF Film Office; Santa Fe County; Randy Randall, rrandall@santafenm.gov, 955-6209

BACKGROUND AND SUMMARY:

We are requesting the approval of Amendment #1 to MOA #20-0162, which was an MOA between Santa Fe County and the City of Santa Fe that provided funding for the jointly funded Film Office in the amount of \$150,000, to be split equally between TSF and Economic Development. For the past four years, the city and county have operated a joint Santa Fe Film Office, funded equally between the two entities and is housed in the County with the County providing office space and support services to the office in addition to their monetary contribution. For the first three years the office has been funded at \$300,000 per year. The City's half of this has been funded equally between Tourism Santa Fe and Economic Development. In FY20 the office was able to be funded at \$200,000 (\$100,000 from each entity as a result of budget cuts related to COVID and staff changes). For FY21, it was determined that there are sufficient cash balances from prior funding to cover the current year, therefore, no additional funding is required for the current fiscal year. The County already has these funds and has asked for the attached MOA which provides authorization from the City to expend our half of the accumulated cash balances that the county has to complete the FY21 operations. The amount in cash balances is \$92,500 from each entity.

The Santa Fe Film Office has proven to be an extremely valuable tool in our response to proposed filming opportunities and ongoing support to all film and media productions. In calendar 2020 it also provided some relief for our diminished visitation as all film and media productions have been deemed "essential" by the Governor with world-wide industry strict Covid Safe Practice requirements in place and enforced. We feel it will help significantly as we see tourism restart in calendar 2021 and continue to be an important part of our economic growth and diversification as the film office continues to bring in various projects with a wide variety of budgets.

**AMENDMENT NO. 1
TO MEMORANDUM OF AGREEMENT
BETWEEN SANTA FE COUNTY AND
THE CITY OF SANTA FE
REGARDING THE OPERATION OF THE SANTA FE REGIONAL FILM OFFICE**

This Amendment is entered into on this ____ day of _____, 2021, by and between **Santa Fe County**, a political subdivision of the State of New Mexico ("County") and the **City of Santa Fe** ("City") or collectively the "Parties".

WHEREAS, the Parties entered into a Memorandum of Agreement No. 2020-0147-CMO/BT (the "MOA") on March 17, 2020, to provide for their agreement to jointly fund the ongoing operations of the Santa Fe Regional Film Office, which the parties established in 2017. The parties have been operating the Santa Fe County Regional Film Office since 2017; and

WHEREAS, Article 6 of the MOA allows the MOA to be amended by an instrument in writing and executed by the parties; and

WHEREAS, since 2017 and as of June 30, 2020, the Parties have contributed \$550,000.00 each for a total of \$1,100,000.00. Of this sum, the Santa Fe Regional Film Office has expended \$908,549.00 leaving a cash balance of \$191,451.00; and

WHEREAS, in 2020 the Parties' budgets have been negatively impacted by the COVID-19 pandemic and the state's emergency health orders. The Parties have had to cut their budgets and have agreed to reduce the budget for the operation of the Santa Fe Regional Film Office to a sum of \$200,000.00 with \$100,000.00 contributed by each Party; and

WHEREAS, the Parties' joint operation of the Santa Fe Regional Film Office since 2017 has resulted in a total of \$191,451.00 in savings which the parties now wish to set forth for expenditure in fiscal year 2021; and

WHEREAS, the Santa Fe Regional Film Office has a fiscal year 2021 budget of \$185,000.00 and the Parties agree to fund that budget with the \$191,451.00 cash balance, therefore eliminating the need for either Party to contribute additional funds for operational expenses for fiscal year 2021; and

WHEREAS, in addition to setting forth the budget for fiscal year 2021, the Parties also wish to extend the term of the MOA to June 30, 2021; and

WHEREAS, both parties wish to enter into this Amendment No. 1.

NOW, THEREFORE, THE PARTIES AGREE TO AMEND THE MOA AS FOLLOWS:

1. Article 1 (Duties of the Parties), subpart A (County's duties) is amended by deleting subpart 3 and replace it with:

3. Provide \$100,000.00 in direct funding for operational expenses of the Santa Fe Regional Film Office in fiscal year 2020.
2. Article 1 (Duties of the Parties), subpart B (City's duties) is amended by deleting subpart 3 and replace it with:
 3. Provide \$100,000.00 in direct funding for operational expenses of the Santa Fe Regional Film Office in fiscal year 2020.
3. Article 1 (Duties of the Parties), insert a subparagraph C to read:

C. By Amendment No. 1 to this MOA, the Parties agree that the \$191,451.00 in savings will be expended based on an annual operating budget of \$185,000.00. Each Party having allocated or budgeted \$92,500.00 for the operational expenses of the Santa Fe Regional Film Office in fiscal year 2021.
4. Article 3 (Term and Termination), subpart A is amended by deleting "2020" and replace it with "2021."
5. All other provisions of the MOA not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.

**MEMORANDUM OF AGREEMENT
BETWEEN SANTA FE COUNTY AND
THE CITY OF SANTA FE**

THIS MEMORANDUM OF AGREEMENT (hereinafter "MOA") is entered on this the 11th day of February 2020, between **SANTA FE COUNTY** (hereinafter "County"), a political subdivision of the state of New Mexico, and the **CITY OF SANTA FE** (hereinafter "City"), collectively the "Parties".

RECITALS

WHEREAS, the film and media industries contribute millions of dollars a year annually to the local and regional economy; and

WHEREAS, local governments benefit from the film industry through job creation, direct collection of gross receipts taxes, leases, permitting and other fees, as well as through global exposure of the region for tourism, business recruitment and other activities; and

WHEREAS, the state of New Mexico and specifically the north-central region, has established itself as a premiere production location for film and television production; and

WHEREAS, resources exist in the region to significantly expand both traditional film/television production, and digital media technologies for both entertainment and non-entertainment applications, posing an attractive opportunity for business retention, recruitment and expansion; and

WHEREAS, no centralized, dedicated servicing entity currently exists at the County/ City level to handle incoming productions or business queries, resulting in confusion and the potential delivery of reduced and/or sub-par services to productions and businesses wishing to locate in the region. This represents a significant impediment to growth in these areas and also a vulnerability to the local program in an increasingly competitive global production environment; and

WHEREAS, in order to maximize revenue, job growth and other benefits to the local economy and government; develop and implement a strategic plan for growth in these and related areas; and represent the interests of the local government before state, national and international legislative bodies and professional forums, it is desirable to create a centralized film office administratively housed at the County and that will service the general Santa Fe region. This is a firmly established tenet of "best practices" in virtually every region of significant production activity throughout the county; and

WHEREAS, in fiscal year 2017, the County and the City jointly established the Santa Fe Regional Film Office.

NOW, THEREFORE, the Parties mutually agree as follows:

1. DUTIES OF THE PARTIES

A. The County shall:

1. Provide direct management and oversight of the staff of the Regional Film Office .
2. Designate a liaison to work collaboratively with City staff through the Regional Film Office.
3. Provide \$150,000.00 in direct funding for operational expenses related to the Regional Film Office in fiscal year 2020.

B. The City shall:

1. Designate a liaison to work collaboratively with the Regional Film Office and County staff.
2. Provide \$150,000.00 in direct funding for operational expenses related to the Regional Film Office in fiscal year 20.

3. TERM AND TERMINATION

- A. This MOA shall, upon due execution by all Parties, become effective as of the date first written above and shall terminate on June 30, 2020, unless earlier terminated as indicated below or extended by the mutual written agreement of both Parties.
- B. This MOA may be terminated by either Party upon delivery of a written notice delivered to the other Party at least 30 days prior to the intended date of termination. By such termination, neither Party may nullify or avoid any obligations incurred prior to termination

4. ASSIGNMENT

Neither Party shall not assign or transfer any interest or rights in this MOA without the advance written approval of the other Party. Any attempted assignment or transfer without the other Party's advance written approval shall be null and void and without any legal effect.

5. LIABILITY

Each Party shall be solely responsible for fiscal or other sanctions occasioned as a result of its own violation of requirements applicable to the performance of this MOA. Each Party shall be liable for its actions in accordance with this MOA. Any liability incurred by the County or the City in connection with this MOA is subject to the immunities and limitations of the New Mexico Tort Claims Act, NMSA 1978, Section 41-4-1, et seq. . The County, City and its public employees as defined in the New Mexico Tort Claims Act, do not waive sovereign immunity; do not waive any defense; and do not waive any limitation of liability pursuant to law. No provision

in this MOA modifies or waives any provision of the New Mexico Tort Claims Act.

6. AMENDMENT

This MOA shall not be altered, changed or amended except by an instrument in writing executed by the Parties.

7. APPROPRIATIONS

The terms of this MOA are contingent upon sufficient appropriations and authorization being made by the Legislature of the State of New Mexico and the governing bodies of the City and the County for the performance of this MOA. If sufficient appropriations and authorization are not made, this MOA shall terminate immediately upon written notice being given by the terminating Party to the other Party. Any Party's decision as to whether sufficient appropriations are available shall be accepted by the other Party and shall be final.

8. GOVERNING LAW

This MOA shall be governed by, and construed in accordance with, the laws of New Mexico and the applicable ordinances of the Parties.

9. ACCOUNTABILITY

During the term of this MOA and for a period of three years thereafter, each Party will maintain accurate and complete records of all disbursements made and monies received by each under this MOA and, upon receipt of reasonable written request, each shall make such records available to the other Party and to the any other parties during regular business hours of the Regional Film Office.

10. NO THIRD-PARTY BENEFICIARIES

Nothing in this MOA, express or implied, is intended to confer any rights, remedies, claims or interests upon a person not a Party to this MOA.

11. SUCCESSORS AND ASSIGNS:

This MOA will inure to the benefit of the Party's successors or assigns.

12. ENTIRE AGREEMENT

This MOA represents the entire understanding between the Parties and supersedes any prior agreements or understandings with respect to the subject of this MOA. No changes, amendments or alterations to this MOA will be effective until in writing and signed by the Parties.

13. NOTICES


